WILL ROGERS TELEPHONE REPORT

BODY OF REPORT:

ON 4/2/10 AT 2358, SGT. QUERRY (1309) AND I RESPONDED TO 701 COLCORD IN REFERENCE TO A RAPE. UPON ARRIVAL, WE MADE CONTACT WITH VI [REDACTED]. VI HAS AUTISM. VI SAID THAT HE HAS A FETISH FOR FLATULENCE, AND WAS ONLINE TRYING TO MAKE FRIENDS THAT HAD THE SAME FETISH FOR "FARTS". VI SAID HE LIKES "THE SOUND AND SMELL OF FARTS". VI WAS LONELY AND JUST WANTED TO MAKE SOME NEW FRIENDS. VI SAID HE MET SU [REDACTED] ONLINE AT AIRG.COM SOMETIME IN JANUARY. SU [REDACTED] USERNAME IS [REDACTED] VI AND SU BECAME FRIENDS AND TALKED ONLINE. VI AND SU EVENTUALLY EXCHANGED PHONE NUMBERS AND STARTED TEXTING.

VI SHOWED ME SEVERAL TEXTS THAT HE HAD SAVED FROM SU. THESE TEXTS WERE ALL FROM FEBRUARY. VI SAID THAT HE AND SU HAD TEXT SEVERAL HUNDRED TIMES BUT HE HAD ONLY SAVED THESE TEXTS. VI DID NOT SAVE THE TEXTS HE SENT TO SU. THE NUMBER SU WAS TEXTING FROM IS [REDACTED] HERE IS A LIST OF THE TEXTS THAT VI SHOWED ME ON HIS PHONE:

VI SAID HE SAVED THESE TEXTS BECAUSE HE THOUGHT HE MIGHT EVENTUALLY NEED THEM AS EVIDENCE. VI SAID HE WAS A LITTLE SCARED OF WHAT SU WANTED TO DO TO HIM SEXUALLY, BUT SU TOLD HIM THAT HE WOULD NOT FORCE HIMSELF ON HIM SO VI THOUGHT IT WAS ALRIGHT TO KEEP TALKING TO SU.

VI AND SU CONTINUED TEXTING AND DECIDED TO MEET IN PERSON. ON 3/27/10 AT APPROXIMATELY 2300 HOURS, VI WENT TO AND PICKED UP SU. THIS ADDRESS IS SU'S MOM'S HOUSE WHERE SU LIVES. VI TOOK SU BACK TO VI'S APARTMENT AT VI SAID THE TWO OF THEM JUST TALKED "LIKE FRIENDS DO" AND GOT TO KNOW EACH OTHER. AFTER ABOUT AN HOUR OF CHATTING, VI TOOK SU BACK TO SU'S MOM'S HOUSE. THEY ARRIVED AT THE HOUSE AROUND MIDNIGHT.

WHEN THEY ARRIVED BACK AT THE HOUSE, SU ASKED VI TO COME INSIDE WITH HIM. VI WENT IN BECAUSE SU SAID HE WOULD "FART FOR ME". VI THOUGHT HE WAS JUST GOING TO GET TO GO IN AND ENJOY SU'S FARTS.

ONCE INSIDE, VI SAID SU "GRABBED ME BY MY BRITCHES AND LED ME INTO HIS BEDROOM". VI SAID THIS MADE HIM "UNCOMFORTABLE" SO HE SAID "I NEED TO GO". AT THIS POINT, SU TOLD VI HE DIDN'T WANT HIM TO GO. SU TOLD VI "I KNOW WHERE YOU LIVE" AND "I WILL BEAT YOU UP AND TAKE YOUR CAR IF YOU TRY TO LEAVE". VI SAID HE GOT SCARED AND DIDN'T REALLY RESIST AGAIN AFTER THAT BECAUSE HE'S "NOT MUCH OF A FIGHTER" AND HE DOESN'T "LIKE GETTING BEAT UP". FROM THEN ON HE ACTED AS IF HE LIKED IT AND SAID THINGS LIKE, "OOO, I LIKE THAT".

VI SAID SU HAD VI "TOUCH HIS", "PUT MY IN HIS", AND "KISS HIM". VI SAID HE HAD TO PUT HIS FINGERS INTO SU'S. SU THEN TOUCHED VI'S AND STARTED RUBBING VI'S AND PUT PART OF HIS HAND INTO VI'S. VI SAID HE WAS NOT SURE IF SU JUST PUT A FINGER OR TWO OR IF IT WAS THE WHOLE HAND BECAUSE "IT WAS DARK AND I COULDN'T SEE WHAT HE WAS DOING". VI SAID, "OUCH, THAT HURTS" AND SU SAID "BE QUIET OR I'LL DO IT AGAIN" AND REPEATED THE SAME THREATS AS BEFORE SAYING "I KNOW WHERE YOU LIVE" AND "I WILL BEAT YOU UP AND TAKE YOUR CAR IF YOU TRY TO LEAVE".

VI SAID SU THEN " FOR ABOUT 5 TO 10 SECONDS". VI STATED "I DIDN'T LIKE IT. I HATE, THEY ARE DISGUSTING". VI SAID SU ALSO "PUT HIS IN MY AND MADE ME PUT MY IN HIS". "IT DIDN'T HURT OR FEEL BAD" LIKE IT DID WHEN SU PUT HIS INSIDE VI'S.
