COUNT 1: ON OR ABOUT THE 24TH DAY OF JANUARY, 2008, A.D., THE CRIME OF MAKING A FALSE
 OR FICTITIOUS OR FRAUDULENT CLAIM AGAINST THE STATE WAS FELONIOUSLY
 COMMITTED IN THE STATE OF OKLAHOMA BY TAMMY L. BASS LESURE, WHO
 KNOWINGLY, WILFULLY AND FELONIOUSLY MADE A FRAUDULENT CLAIM FOR
 PUBLIC FUNDS IN THE FORM OF FOSTER CARE REIMBURSEMENT PAYMENTS AGAINST
 THE STATE OF OKLAHOMA, TO WIT: TAMMY L. BASS LESURE FRAUDULENTLY
 REPRESENTED FACTS AND CONTRACTED WITH THE STATE OF OKLAHOMA TO
 PROVIDE FOSTER CARE SERVICES FOR E.W. AND J.W. MINOR CHILDREN, VIA A
 DEPARTMENT OF HUMAN SERVICES FIXED RATE REGULAR FOSTER CARE CONTRACT
 WHEREIN SHE MADE A CLAIM FOR THE REPEATED PAYMENT OF PUBLIC FUNDS IN THE
 FORM OF FOSTER CARE REIMBURSEMENT PAYMENTS. MORE SPECIFICALLY, SHE

FURTHER THESE FRAUDULENT CLAIMS CONTAINED IN THE APPLICATION AND AGREEMENT WERE MADE BY TAMMY L. BASS LESURE WHILE INTENDING TO CONTINUE TO KEEP THE PHYSICAL CUSTODY, CARE, AND SUPPORT OBLIGATIONS FOR THE CHILDREN WITH THE PERSON IDENTIFIED AS, R. B. A/K/A E. TAMMY L. BASS LESURE MADE THESE FRAUDULENT CLAIMS AND TOOK REPEATED ACTIONS CONSISTENT THEREWITH WHILE INTENDING TO SUPPRESS THE TRUTH REGARDING THE PLACEMENT, CARE, AND SUPPORT OF SAID CHILDREN FROM THE OKLAHOMA DEPARTMENT OF HUMAN SERVICES AND THE OKLAHOMA COUNTY JUVENILE DISTRICT COURT THROUGH TRICK, FALSE APPEARANCE, AND/OR OTHER UNFAIR ACTS IN ORDER TO CHEAT THE STATE OF OKLAHOMA, AND AGAINST THE PROVISIONS OF SECTION 358 OF TITLE 21 OF THE OKLAHOMA STATUTES, AND AGAINST THE PEACE AND DIGNITY OF THE STATE OF OKLAHOMA;


