That **TIM HARRIS**, the duly elected and qualified **District Attorney for Tulsa County, Oklahoma**, who prosecutes in the name and by the authority of **The State of Oklahoma**, comes now into the District Court of Tulsa County, State of Oklahoma, and gives the Court to understand and be informed that:

**(COUNT 1)**

**21 O.S. 701.7**

**JACOB CARL ENGLAND and ALVIN LEE WATTS**, on or about **4/6/2012**, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **MURDER IN THE FIRST DEGREE**, a Felony, by unlawfully, feloniously, and willfully while acting in concert each with the other, with malice aforethought, without authority of law, effect the death of Dannaer Octivia Fields by shooting her in the chest then and there and thereby inflicting certain mortal wounds in the body of said Dannaer Octivia Fields from which mortal wounds the same Dannaer Octivia Fields did languish and die on the 6<sup>th</sup> day of April, 2012,

**(COUNT 2)**

**JACOB CARL ENGLAND and ALVIN LEE WATTS**, on or about **4/6/2012**, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **MURDER IN THE FIRST DEGREE**, a Felony, by unlawfully, feloniously, and willfully while acting in concert each with the other, with malice aforethought, without authority of law, effect the death of Bobby Lynn Clark by shooting him in the chest then and there and thereby inflicting certain mortal wounds in the body of said Bobby Lynn Clark from which mortal wounds the same Bobby Lynn Clark did languish and die on the 6<sup>th</sup> day of April, 2012,

**JACOB CARL ENGLAND and ALVIN LEE WATTS**, on or about **4/6/2012**, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **MURDER IN THE FIRST DEGREE**, a Felony, by unlawfully, feloniously, and willfully while acting in concert each with the other, with malice aforethought, without authority of law, effect the death of William Terrell Allen by shooting him in the chest then and there and thereby inflicting certain mortal wounds in the body of said William Terrell Allen from which mortal wounds the same William Terrell Allen did languish and die on the 5<sup>th</sup> day of April, 2012,

**JACOB CARL ENGLAND and ALVIN LEE WATTS**, on or about 4/6/2012, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **SHOOTING WITH INTENT TO KILL**, a Felony, by unlawfully, feloniously, willfully, knowingly, and intentionally, while acting in concert each with the other, attempt to kill one Deon Lawayne Tucker by then and there shooting him with a firearm, to-wit: a pistol the same being a deadly weapon loaded with gunpowder and shot, held in the hands of said defendants and which they wrongfully and intentionally pointed, aimed and fired at the said Deon Lawayne Tucker the bullet therefrom, striking, penetrating and causing wounds in the shoulder of the said Deon Lawayne Tucker with the unlawful, wrongful, willful and felonious intent then and there on the part of said defendants to kill Deon Lawayne Tucker,

**JACOB CARL ENGLAND and ALVIN LEE WATTS**, on or about 4/6/2012, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **SHOOTING WITH INTENT TO KILL**, a Felony, by unlawfully, feloniously, willfully, knowingly, and intentionally, while acting in concert each with the other, attempt to kill one David Wayne Hall by then and there shooting him with a firearm, to-wit: a pistol the same being a deadly weapon loaded with gunpowder and shot, held in the hands of said defendants and which they wrongfully and intentionally pointed, aimed and fired at the said David Wayne Hall the bullet therefrom, striking, penetrating and causing wounds in the stomach of the said David Wayne Hall with the unlawful, wrongful, willful and felonious intent then and there on the part of said defendants to kill David Wayne Hall,

**JACOB CARL ENGLAND and ALVIN LEE WATTS**, on or about 4/6/2012, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **MALICIOUS INTIMIDATION OR HARRASSMENT**, a misdemeanor, by unlawfully, maliciously, willfully, wrongfully and intentionally, while acting in concert each with the other, and without justifiable or excusable cause, intimidate, harass and did commit a battery which is any willful and unlawful use of force or violence against Bobby Lynn Clark, to wit: Defendants shot him with a pistol causing him to be hit with a bullet because of Bobby Lynn Clark's race, color, ancestry or national origin,

JACOB CARL ENGLAND and ALVIN LEE WATTS, on or about 4/6/2012, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of MALICIOUS INTIMIDATION OR HARRASSMENT, a misdemeanor, by unlawfully, maliciously, willfully, wrongfully and intentionally, while acting in concert each with the other, and without justifiable or excusable cause, intimidate, harass and did commit a battery which is any willful and unlawful use of force or violence against William Terrell Allen, to wit: Defendants shot him with a pistol causing him to be hit with a bullet because of William Terrell Allen's race, color, ancestry or national origin,


