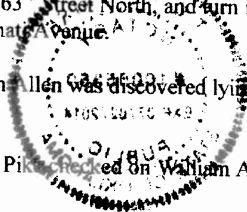

The undersigned, of lawful age, being first duly sworn, upon oath deposes and states as follows:

1. He is a Tulsa Police Officer currently assigned to the Detective Division as a Homicide Detective and has read certain official investigative reports and statements of witnesses regarding the above named defendant(s) and, from these statements and reports it appears as follows:
2. That the following offense(s) occurred in the City of Tulsa, Tulsa County, State of Oklahoma.
3. On April 6, 2012 Tulsa Police Officers were dispatched to shootings at the following locations.
 - 1390 E 51st Place North.
 - 1045 E 51st Place North.
 - 310 W 63rd Street North.
 - 801 E 36th Street North.
4. Deon Tucker was shot in the chest and David Hall was shot in the stomach at 1390 E 51st Place North.
5. I interviewed Deon Tucker at Saint Francis Hospital on April 6, 2012 and he provided the following information about the individual that shot him.
 - He and his friend David were on his porch at approximately 0100 hours when a white truck pulled up in front of his house.
 - An individual that looked like a white male was driving the white truck.
 - The white male asked for directions.
 - He told the white male the address he was looking for was down the street.
 - He walked away from truck and heard three shots and realized he had been shot.
 - The white truck drove westbound from his house.
6. Detective Regalado interviewed Deon Tucker later in the day at Saint Francis Hospital. Tucker provided the following information:
 - The driver of the white truck was described as a white male with a round face and shaved head.
 - The truck had a loud exhaust.
 - Shortly after he was shot he heard another gunshot to the west of his location.
7. Dannaer Fields was discovered in front of 1045 E 51st Place North. The location is approximately 1/2 mile from 1390 E 51st Place North and transported to St. John Hospital and pronounced dead at approximately 0330 hours.
8. Bobby Clark was found lying in the road at near 310 W 63rd Street North and transported to Hillcrest Hospital.
9. Medical personnel discovered Bobby Clark had an apparent gunshot wound to his chest and he was pronounced dead at approximately 0246 hours.
10. Detectives discovered and interviewed a witness that stated they heard a gunshot, sometime after midnight on April 6, 2012, and saw a white truck with a loud exhaust drive eastbound out of the neighborhood, near 310 W 63rd Street North, and turn its headlights out. The vehicle was then driven northbound on North Cincinnati Avenue.
11. William Allen was discovered lying face down in front of 801 E 36th Street North by Tulsa Police Officer Pike.
12. Officer Pike checked on William Allen and discovered that he was deceased at approximately 0824 hours.



13. Medical Examiner Investigator Kelly arrived at the location to conduct her investigation. She discovered William Allen had a gunshot wound to the chest.
14. On April 6, 2012 I interviewed William Allen's wife, Janette Allen. She stated William Allen did not come home on the night of April 5, 2012.
15. Janette Allen stated he observed a white truck with a loud exhaust being driven by a white male speeding south bound on North Hartford near 49th Place North on April 6, 2012 at approximately 0620 hours while she was waiting at the bus stop near this location.
16. The Tulsa Police Department has received several Crime Stopper tips since the shooting about the incident.
17. This is a synopsis of one of the Crime Stoppers tips received on April 7, 2012:
 - Caller believes Jake England should be a person of interest for the shootings that took place on April 6, 2012.
 - Caller states Jake England is a racist and hates black males.
 - Caller stated Jake England has bragged about other shootings.
 - Caller advised a black male shot and killed Jake England's father two years ago.
 - The shooting may have been revenge for the death of his father.
 - Jake England lives on 63rd Street North.
 - Jake England has two shotguns, a .22 caliber handgun, and other handguns.
 - Jake England has mentioned he will die in a shoot out with the police if he has to.
18. Detectives researched this information and discovered that Jacob England's father, Carl England, was shot and killed by Parnell Jefferson in the Comanche apartment complex on April 5, 2010.
19. Parnell Jefferson is a black male.
20. Tulsa Police received a second Crime Stoppers tip that stated Jake left two or three hours ago to burn his truck near 86th Street North and Lewis. The Caller thinks Jake will go back to his house near O'Brien Park and wait for police.
21. On April 7, 2012, Osage County Sheriff Deputies discovered a 1989 Chevy truck, Cherokee Nation license plate 4128C, on fire near 6000 North Osage. One of the registered owners is Jacob England 2800 East 61st Street North.
22. Tulsa Police received a third Crime Stoppers tip on April 7, 2012 that stated the following:
 - Jacob England has made several comments about killing black people.
 - Jacob England's father was killed by a black male and he wants justice.
 - Jacob England has told several family members that he needed to burn his truck.
 - Jacob England may go a cemetery in Skiatook where his wife is buried.
 - Jacob England has made comments about killing black people.
 - Jacob England uses drugs and will not go down without a fight.
 - Jacob England's phone number is 918-734-3678.
23. Tulsa Police confirmed that Jacob England's fiancé, Sheran Wilde committed suicide on January 10, 2012.
24. Tulsa Police discovered that Jacob England made the following post on his Facebook account on April 5, 2012, "Today is two years that my dad has been gone shot by a fucking nigger it's hard not to go off between that and sheran I'm gone in the head."
25. The defendant, **Jacob Carl England**, is described as; a white male, 5'05", 155 lbs, brown hair, brown eyes, date of birth August 9, 1992, ~~828223702-2997~~ last known address 2800 E 61st Street North, Tulsa, Oklahoma.

WHEREFORE, affiant prays this Honorable Court to issue a warrant for the arrest of the within named Defendants(s), that he/she/they may be brought before a magistrate and held to answer for the offense(s) of:

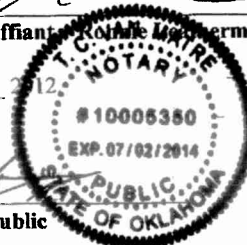
