1. I, and my passenger(s), if any (to include “we”, “me”, “my” “mine”, “us” and/or “our(s)”), understand and accept that certain activities associated with the “Thunder into Louisville” event (the “Ride”), could expose us to numerous known, unknown and unanticipated risks which could result in personal injury, illness or death to, and/or damage to our property and the property of others.
2. I/we understand and accept that this Ride has been organized by Independence Television Co., the Boy Scouts of America, other associated companies, subsidiaries, additional sponsors, their employees, associates and assigns.
3. I/we assume the responsibility for the decision to participate in the Ride and have freely chosen to participate, despite the risks associated with it. I/we assume the risks associated with the Ride, as well as the risks of any activities in which I/we may participate during the Ride.
4. I/we understand that operating a motorcycle during the Ride may subject me/us to physical exertion, and I attest, as operator of the motor vehicle involved, that I am in sufficient physical condition to accept the level of physical exertion that may be required.
5. I/we understand and agree that the Sponsors are not responsible for any damage or loss of property, including but not limited to motorcycle or personal property, incurred by the transportation of my/our property.
