

OFFICIAL PROMOTION RULES Teen to Watch- -WXTX 2010

1. Promotion Description. The promotion begins at **02/12/2010** and ends at **06/01/2010**. NOTE: Entries must be received by **06/01/2010**. Promotion is void where prohibited. By entering, each entrant accepts and agrees to be bound by these promotion rules.
