

CHECK US OUT SWEEPSTAKES

Official Contest Rules - 2019

1) NBC29's Check Us Out Sweepstakes is a watch-and-win promotion open to persons 18 years of age and older. Void where prohibited or restricted by applicable federal or state laws and regulations. Virginia Broadcasting LLC employees, participating advertisers, and their immediate family members are not eligible to win.

2) Official entry forms are included in the contest brochure. Copies of the contest brochure may be picked up, if not received by mail, at NBC29 studios (503 E. Market St., Charlottesville, VA) during regular business hours (Monday through Friday, 9AM to 5PM). No purchase necessary. Limit one brochure at pickup per person. Supply is limited. Entry forms may also be obtained on NBC29's official website (www.nbc29.com). Not responsible for lost or stolen entries. Only one entry per envelope is accepted. Only completed and legible entries are eligible to win.

3) Names of potential winners are announced weekdays beginning Wednesday, January 30, 2019. Names are drawn at random during selected NBC29 news broadcasts. Grand prize winner will be announced on Wednesday, February 27, 2019. Each contestant whose name is drawn has 29 minutes to call NBC29 on a designated phone line to claim prize (contest line is 434-220-2990). All callers must be willing to provide their name, address and phone number over the phone to verify caller's identity.
