4. The material facts constituting probable cause that the search should be made are:

On 1/31/14 the Waynesboro Police Department was notified through the family of Kevin Wayne Quick that he was currently being reported missing to the Nelson County, Virginia Sheriff's Office. The investigation revealed that he last had a 2 text phone conversation with his child's mother, Yadi Weaver. That conversation was that he was on the way there to her residence in Albemarle County, Virginia. He never arrived at her residence. An emergency phone trace on Quick's known Verizon wireless mobile number was conducted through the request of the Nelson County Sheriff's Office to Waynesboro Police Department. The results of this trace show his phone has been turned off since Friday, January 31st at 2254hrs. There is no additional usage of the phone and per Verizon the phone is not currently turned on. Per family members, Quick only uses his Discover card to make transactions. Discover was contacted and his card had not been used since around 1745 hrs. on 1/31/14. 3 weeks ago, Quick was laid off from his employer at Invista and was provided with a severance package of an unknown amount. The money from the severance package has not yet been accounted for. Quick has at least one account with Dupont Community Credit Union. This account so far has not been able to be accessed. This account could contain information on purchases or transactions that could assist with locating Quick. The information could also aide in establishing where he did or is travelling to and also help add valuable information in establishing a timeline of this event. Given the fact that Dupont Community Credit Union is located within the corporate limits of the City of Waynesboro and that Nelson County Sheriff's Office has requested our assistance with locating Quick a search is requested based off of this information.
