

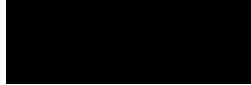

CHARGES: R.S. 14:(25)64.3, ACCESSORY TO ARMED ROBBERY WITH A FIREARM.

ON NOVEMBER 20, 2015 AT ABOUT 4:00 A.M. SIXTH DISTRICT OFFICERS RESPONDED TO AN ARMED ROBBERY WITH A FIREARM AND SHOOTING AT THE INTERSECTION OF ST. MARY AND MAGAZINE STREET. OFFICERS OBSERVED A MALE VICTIM WHO SUFFERED A GUNSHOT WOUND TO THE CHEST AND THE FEMALE VICTIM WHO STATED THAT SHE WAS ROBBED OF HER PROPERTY. THE MALE VICTIM WAS TRANSPORTED TO THE HOSPITAL. THE UNKNOWN PERPETRATOR OF THE INCIDENT FLED THE SCENE.

ON NOVEMBER 22, 2015 DETECTIVE WALTER EDMOND CRAFTED AN ARREST WARRANT FOR THE PERPETRATOR OF THE INCIDENT. DET. EDMOND WAS ABLE TO IDENTIFY THE PERPETRATOR AS MR. EURIC CAIN (B/M 5/12/1994). ON NOVEMBER 22, 2015 MR. CAIN'S WANTED STATUS WAS BROADCASTED VIA SEVERAL NATIONAL AND INTERNATIONAL NEWS MEDIA OUTLETS.

ON NOVEMBER 23, 2015 MR. CAIN WAS APPREHENDED AT [REDACTED] VIA THE US MARSHALS. US MARSHAL AGENTS CAME IN CONTACT WITH TWO FEMALE SUBJECT WHO WERE IN THE RESIDENCE. DET. EDMOND CONDUCTED A INTERVIEW WITH MS. NICTORIA WASHINGTON WHO IDENTIFIED HERSELF AS THE GIRLFRIEND OF MR. CAIN. DET. EDMOND ADVISED MS. WASHINGTON OF HER RIGHTS AS THEY PERTAIN TO MIRANDA. MS. WASHINGTON ACKNOWLEDGED THAT SHE UNDERSTOOD HER RIGHTS. DET. EDMOND INQUIRED TO MS. WASHINGTON AS TO WHEN SHE FOUND OUT MR. CAIN WAS WANTED BY THE NEW ORLEANS POLICE DEPARTMENT. MS. WASHINGTON STATED THAT ON NOVEMBER 22, 2015 LATE THAT NIGHT SHE ANSWERED A PHONE FROM MR. CAIN'S PHONE. MS. WASHINGTON STATED THAT A FRIEND OF MR. CAIN WAS ON THE OTHER LINE AND INFORMED HER THAT MR. CAIN WAS CURRENTLY WANTED BY THE POLICE FOR SHOOTING SOMEONE. MS. WASHINGTON STATED THAT SHE WAS THEN NOTIFIED AGAIN ON NOVEMBER 23, 2015 BY HER SISTER VIA PHONE THAT MR. CAIN WAS WANTED BY THE POLICE. DET. EDMOND ASKED MS. WASHINGTON WHY SHE DID NOT NOTIFY THE POLICE ONCE SHE WAS TOLD THAT MR. CAIN WAS WANTED. MS. WASHINGTON STATED THAT SHE DID NOT WANT GET MR. CAIN IN TROUBLE AND THAT SHE WAS AFRAID TO SAY SOMETHING.

MS. WASHINGTON WAS ADVISED THAT SHE WAS UNDER ARREST FOR ACCESSORY TO ARMED ROBBERY. DET. EDMOND COMPLETED NECESSARY PAPERWORK FOR MS. WASHINGTON. MS. WASHINGTON WAS LATER BOOKED ACCORDINGLY.
